

S.O. 4990(E).—In exercise of the powers conferred by section 3 read with clause (b) of section 2 of the Live-stock Importation Act, 1898 (9 of 1898), the Central Government hereby makes the following further amendment in the notification of the Government of India, in the Ministry of Agriculture, Department of Animal Husbandry, Dairying and Fisheries, published in the Gazette of India, Extraordinary, Part II, section 3, sub-section (ii), *vide* number S.O. 1495 (E), dated the 11th June, 2014, namely:—

In the Schedule to the said notification, in paragraph 1, in proviso, for word, letters and figures “30th June 2022”, the word, letters and figures “31st March 2023” shall be substituted.

EXPLANATORY MEMORANDUM

By substituting the period referred to in the proviso to paragraph 1 of the Schedule to the notification *vide* number S.O. 1495 (E), dated the 11th June, 2014, from “30th June 2022” to “31st March 2023”, the interest of no persons shall be adversely affected.

Note: The principal notification was published in the Gazette of India, Extraordinary, Part II, Section 3, sub-section (ii), *vide* notification number S.O. 1495 (E), dated 11th June, 2014 and subsequently amended *vide* notification number S.O. 4025 (E), dated the 6th November, 2020, S.O. 2825 (E), dated 14th July, 2021 and S.O. 489 (E), dated 4th February, 2022.
