This addendum refers to the tender invited for selection of agencies/firms for Providing Housekeeping & Conservancy services at CIAL.

The following changes have been incorporated in the Tender Document No. CIAL/COML/HK/2024 for Housekeeping and Conservancy Services at Cochin International Airport, through addendum No: 01

1. The tender submission date has been extended to 07th May 2024, 14:00 hrs. and the bid opening will be on 07th May 2024 at 14:30 hrs.
2. In Page 41 of tender document, under the section III-Scope of Work of Housekeeping Agency in International Arrival of T3, the clause “Arrival Pier area including AOCC Room” is replaced by “Arrival Pier area.”
3. In Page 47 of tender document, under the section IV-Scope of Work of Housekeeping Agency-Ancillary Buildings, the clause “Air side Verandah, Aprons, Road, makeup, breakup areas – removing FODs oil spills etc.” is replaced by “Air side Verandah, AOCC and other airside CIAL offices, Aprons, Road, makeup, breakup areas – removing FODs oil spills etc.”
4. In Page 56 of Tender document, Annexure 7(a)-Manpower Deployment Sheet-Domestic Terminal-The Total number of manpower shall also include the supervisory staff, though not mentioned separately.
5. In Page 65 of Tender document, Annexure 7(d)-Manpower Deployment Sheet-Ancillary buildings-The Total number of manpower shall also include the staff & Supervisor(s) allocated for airside housekeeping activities, though not mentioned separately.
6. Please submit along with your tender, this Addendum-01 document duly signed and stamped as a token of your acceptance of the terms and conditions stated herein above and has to be submitted in Cover 1.
7. This Addendum shall form an integral part of the Tender No. CIAL/COML/HK/2024.
8. All other terms and conditions of the original tender document shall remain the same.
