- a) The applicant shall have demonstrable experience in the execution of works involving:
  - Public art installations
  - Sculptures
  - Thematic installations
  - Architectural or design-integrated artworks
- b) The applicant should have a minimum of Five (5) years of experience in the field of sculpture works, public art installations, or similar design-led projects.

- c) The applicant should have successfully completed at least one (1) single work order of similar nature of value more than ₹1 Crore in any one of the last Five (5) financial years.
- d) For the purpose of this EoI, “similar work” shall mean projects involving fabrication and installation of large-scale sculptures, artistic installations, or design-led elements integrated within public, commercial, or institutional environments.
- e) CIAL reserves the right to verify the submitted documents and credentials, including seeking additional clarifications or conducting independent reference checks.
